DPF 318 is digitally printable with a wide variety of printers using solvent, eco-solvent, and UV inks. The finish yields high quality print resolution. The banner is both tear and curl resistant, and it is RF weldable. DPF 318 has an outdoor durability of up to 1 year (unprinted). Printed durability is dependent on the ink system used.
